Are there services covered before you meet your <a href="#">deductible</a> ? The <a href="#">out-of-pocket limit</a> is the most you could pay during a coverage period (usually one year) for your share of the cost of covered services. This limit helps you plan for health care expenses. The federal <a href="#">maximum out-of-pocket</a> is \$9,100 individual/\$18,200 family.
